Whereas, the MOU was executed on 11th November, 2013 and came into force and effect on the date for a period of three years; and Whereas, in the light of the positive outcome of cooperation between CARE and VISTAS, both parties desire to extend the MoU for a further period of three years effective from 12th November, 2016 on the same terms and conditions as originally set forth in the MoU, except the Amendment written below:

Clause 19 of the MoU shall be deleted and replaced in its entirety with the following:

VISTAS shall pay to CARE a sum of Rs.5,500/- (Rupees five thousand and five hundred only) per student per academic year as charges for imparting training and internship to the students of VISTAS.

The copy of the said MoU has been annexed to the present Extension of Agreement being an integral part of it.

This Agreement is executed and signed in two counterparts — one for each Party. Both counterparts are equally valid.


