The University of VISTAS (VELS UNIVERSITY) and Sri Ramachandra University desiring to expand scholarly ties and promote mutual understanding, agree to encourage academic exchange and cooperation under the following conditions:-

1. The Institutions will encourage projects and initiatives that will advance the educational and developmental interests of both Institutions of higher learning.
2. Both Institutions agree to have exchange of faculties subject to availability. Both Universities will meet all related costs of their respective faculty. The Institutions agree to provide study/research space and library privileges to such faculty.
3. The Institutions will encourage the exchange of academic, research and instructional materials.
4. The Institutions will encourage faculty to develop joint research projects and to participate in conferences, seminars and discussions.
5. Student exchanges may require a supplementary agreement, specifying the terms of the exchange.

This agreement constitutes the entire agreement between the parties. This agreement is not a contract creating legal and financial relationships between the parties. Rather, it is designed to facilitate and develop a genuine and mutually beneficial academic exchange.


