WHEREAS

1. Term of the MOU:

- 6 This MOU sets forth the general roles and responsibilities that the parties propose to follow as they cooperate in the exchange of information in order to collaborate further to do the following:
- a) Ideal Sensors will provide their expertise for UG, PG programme and in the new areas of research in the field of electronics
 - b) Ideal Sensors will provide PSoC certification program to students of Engineering at VISTAS to deserving students by mutually agreed by both the parties. The modalities will be decided by both the parties
 - c) Host or participate in technical seminars/workshops/conferences jointly with the intention to promote science and practice of engineering and allied sciences, wherein technical literature is presented in the fields of engineering and, in particular digital electronics customized hardware development using embedded system and emulators.
 - d) Ideal Sensors will offer student internships based on an available basis to 2 to 3 students at VISTAS in the area of semiconductor design, process design, quality assurance, foundry, FPGA design and software design for a period of 4-6 months.
 - e) VISTAS will initiate to start the centre of excellence or any other research and development activities/project to execute in special areas like hardware and hybrid processing technologies. VISTAS will be utilizing the expertise from Ideal Sensors.
 - f) Ideal Sensors will provide suitable posters depicting the technology relevant for UG/PG labs.

7 Media Release

Any use of the VISTAS' or Ideal Sensors' brand names, trade names, service names, trademarks, service marks, and the like, must be agreed in writing on a case-by-case basis. Each such agreement may set-forth the applicable terms and conditions. The receiving/publishing party will provide the other party up to fourteen (14) days or such other mutually agreed time to review a copy of any proposed public release of information resulting from collaborative projects and to permit the other party to designate all or any part of the information as not subject to disclosure. All designated restricted material will be protected from disclosure.

8 **Term and Termination**

The MOU shall be effective from the date of signing this MOU; and shall be valid for an initial term of two years, unless terminated earlier by either party. The initial term of this MOU will be automatically extended for additional consecutive periods of one year, unless terminated upon written notice by either party. The notice of early termination or termination at the end of the initial or any extension period should be issued at least 90 days before the intended date of termination and such termination will be without liability.

- 9 The parties understand that nothing herein shall be construed as a binding contract between the parties until such time as duly authorized representatives of the parties hereto execute a formal written agreement with respect to the subject matter of this MOU. The parties further understand that (i) the activities intended by this MOU may not be successfully completed; (ii) the results achieved may not be as anticipated. Neither party shall be liable for any direct, indirect, punitive, special, incidental or consequential damages arising out of or in connection with this MOU, whether for breach of this MOU or in torts, including loss of business, data, revenue, profits, or for any third party claims against the other whatsoever.
- 10 This MOU shall not be construed to be an agency or a partnership or joint venture or an employment relationship. Neither party shall be entitled to bind the other party with any third party by its actions, unless it has specifically obtained the prior written consent of such other party to do so.
- 11 Each party is an independent contractor, and nothing under this MOU shall be construed to create an employment relationship, whether for tax or for any other purpose, nor any partnership or joint venture between the parties. No provision of this MOU grants either party any express or implied right of authority to assume or create any obligations or responsibility on behalf of or in the name of the other party, or bind the other party in any manner or thing whatsoever. Neither party nor its personnel shall be considered employees of the other.
- 12 Neither party shall assign or transfer this MOU without the prior written consent of the other party.
