
WHEREAS

 2. Workshops and career prospects in learning biological softwares in Bioinformatics.


Term of the MOU:

- 7 This MOU or any action of the parties with respect thereto does not constitute legally binding obligations by both the parties. It only intends to lay out the spirit and understanding of the arrangement for mutual benefit of the respective parties.
- 8 This MOU does not create any partnership, agency, joint venture or employer –employee relationship between the parties.
- 9 The parties shall be responsible for their respective costs, loss and expenses and no party shall be responsible to the other for any loss, cost, expense or damages whether direct, indirect, consequential or incidental.




