I. Purpose of the Agreement

 - 1.2. Development of diagnostic kits in the field of Biochemistry, Molecular Biology and Immunology.
 - 1.3. Design and development of electrophoresis unit for molecular biology and other biotechnology equipments.
2. Both parties exchange the technical expertise such as experimental procedures, instrumental knowledge and development of new protocols in Fields.
3. Both parties agree to exchange the expertise of their working staff under mutual convenience when requested by either Party. For example, Abbes Biotech can request to utilize the expertise of VISTAS faculty for their technical events. However, exchange of faculties or scientist to be done under mutual convenience of the Parties when such exchanges doesn't affect the normal functioning of the Parties.
